VIP Dental Membership Program Agreement

This agreement outlines the **terms and conditions** of the *VIP Dental Membership Program* offered by Richmond Landing Family Dentistry.

1. Program Description

The VIP Dental Membership Program is a **direct membership program offered exclusively by Richmond Landing Family Dentistry** to provide patients with access to preventive dental services and discounts on additional dental treatment provided at this office.

This membership program is **not dental insurance**, is **not a qualified health plan under the Affordable Care Act**, and **cannot be used in conjunction with dental insurance or any other discount plan**.

Membership benefits are valid only at **Richmond Landing Family Dentistry** and may not be transferred to another dental provider.

2. Membership Term

Membership is valid for **12 months from the enrollment date**. All membership fees must be paid according to the selected payment schedule.

Membership benefits expire if the membership becomes inactive, canceled, or unpaid.

Membership is **non-transferable** and applies only to the enrolled patient.

3. Included Preventive Services

Membership includes certain preventive services such as examinations, necessary diagnostic radiographs, professional cleanings, and preventive evaluations as outlined in the office's **VIP Membership Service Schedule**.

Services are provided based on **clinical necessity as determined by the treating dentist** and according to standard professional guidelines.

Preventive services included in the program **have no cash value and cannot be exchanged for credit or refund if unused**.

4. Treatment Discounts

Members receive **10% off the office's standard fees for most additional dental procedures**, including restorative and specialty treatments.

Discounts apply only to services provided at Richmond Landing Family Dentistry and **cannot be combined with dental insurance, third-party financing discounts, or other promotional offers.**

Laboratory fees and certain specialty services may be excluded from discount eligibility.*

5. Payment Terms

Membership fees are due at the time of enrollment and according to the selected payment plan.

Failure to maintain monthly payments may result in termination of membership. If a membership is terminated, the one-time enrollment fee will apply again should the patient choose to re-enroll in the future.

Richmond Landing Family Dentistry makes no representation that membership fees qualify as **HSA/FSA-eligible expenses**. Eligibility is determined solely by the patient's plan and applicable Internal Revenue Service (IRS) regulations. The **patient assumes all responsibility** for use of HSA/FSA funds.

6. Refunds and Cancellation

Membership fees are **non-refundable once preventive services have been provided.**

If membership is canceled before the end of the membership period, any services already received will be charged at the **office's standard fees**, and the patient will be responsible for the difference between those fees and the amount paid under the membership plan.

Unused membership benefits **expire at the end of the membership term and cannot be carried forward.**

7. Acknowledgment

Program Disclaimers

This membership program is a **direct patient membership program offered exclusively by Richmond Landing Family Dentistry**. It is **not dental insurance**, is **not a qualified health plan under the Affordable Care Act**, and is **not subject to regulation as insurance**.

Membership benefits are available **only for services provided at Richmond Landing Family Dentistry** and may not be used at any other dental office or provider.

Payments using **HSA or FSA funds** are permitted; however, Richmond Landing Family Dentistry does not determine or guarantee eligibility of membership fees or services under Internal Revenue Service (IRS) guidelines. Patients are solely responsible for verifying qualified expenses with their plan administrator.

Membership Eligibility

Membership is available to patients who enroll directly with Richmond Landing Family Dentistry and agree to the **terms and conditions** of the membership program. Membership benefits apply **only to the enrolled individual and are not transferable** to another person.

***Exclusions & Discount Limitations**

Membership discounts apply only to services rendered at Richmond Landing Family Dentistry and are not valid for any services provided by referred specialists or outside providers. Discounts do not apply to prescriptions, medications, or any products filled or purchased through a pharmacy. For procedures involving gold restorations, the membership discount applies only to the clinical crown fee and does not apply to the cost or value of the gold or other precious metal components. Discounts may not be combined with any other offers, promotions, third-party financing arrangements (including CareCredit), insurance benefits, or reduced-fee programs. Only one discount or offer may be applied per service, and discounts cannot be stacked, duplicated, or applied retroactively.

Membership Term

Membership is valid for **twelve (12) months from the enrollment date**.

Membership fees are due according to the selected payment option. Failure to maintain payment may result in **termination or suspension of membership benefits**.

Included Preventive Services

Membership includes certain preventive dental services as outlined in the Richmond Landing Family Dentistry Membership Program Schedule. Services are provided **based on clinical necessity and professional judgment of the treating dentist**.

Discounted Treatment

Members receive **reduced fees for most dental procedures provided at Richmond Landing Family Dentistry**. Discounts apply only to services performed at this office and **cannot be combined with dental insurance benefits, discount programs, or promotional offers**.

Non-Insurance Disclosure

This membership program **does not provide insurance coverage**. Members are responsible for payment of all services received. The membership program simply provides **access to certain preventive services and reduced fees for additional dental treatment**.

Cancellation and Refund Policy

Membership fees are **non-refundable once services have been provided**. If membership is canceled before the end of the membership period, any services received will be **recalculated at the office's standard fees**, and the member will be responsible for any balance due.

No Cash Value

Membership benefits **have no cash value**, are **non-transferable**, and **expire at the end of the membership term if unused**.

Clinical Determination

All dental services provided under this membership program are subject to **clinical determination and professional judgment of the treating dentist**.

The membership program is intended to **encourage regular preventive dental care and improve access to treatment** for patients without dental insurance.
